

Bunkhouse Community Expectations and Rules

The Bunkhouses are comfortable, summer camp style housing, which naturally offer camaraderie and fun. We have booked both bunkhouses, “The Roost” and “The Rookery” and the hospitality building next door, which I’m calling the “Aviary,” so those buildings should only be occupied by folks with our law school.

A room full of bunk beds and shared bathrooms doesn’t offer much privacy, so we must be clean and considerate, and agree to a few rules. Royalty and light sleepers will probably be more comfortable at a hotel. No judgement, your majesty ;)

Expect

Sleeping

We have two bunkhouse buildings each with 32 bunks (16 top and 16 bottom bunks). Bunks are twin size in shared space with zero noise privacy. Each bunk is in a cubby like area with no door, so there is some, but not complete visual privacy. There is individual storage with each bunk but nowhere to lock up valuables. Good Law is not responsible for lost or stolen valuables.

People will snore, talk in their sleep, go potty in the night, etc. **Bring ear plugs.**

We don’t know how many people will chose to stay in the bunkhouses. We expect to have vacant bunks and some room to spread out, but who knows. The initial plan is to use one bunkhouse for women and girls and the other for men and mix groups, like couples and families. So men probably won’t have an entirely gender segregated space and woman might not. **Bring and wear PJ’s and a robe.**

Bed linens, blankets and towels are provided. However, bring what you need to be comfortable.

Bathrooms

Each bunkhouse has 4 individual bathrooms and 4 individual showers, with real doors. That is plenty, but at peak times, you might have a brief wait. Belongings can’t be left in the bathrooms. The bathrooms and showers will be clean at the beginning of our 3-night stay. We must keep them clean in the interim or be grossed out by Saturday.

There is a washer/dryer. If you think you may want to wash clothes, **bring detergent.**

Living Space and Down Time

Right next to the bunkhouses is the Aviary, a building for socializing with living space and porches. We have rented that whole building too for breakfast, happy hour, and a hospitality area for all seminar attendees. Bunkhouse residents can hang out and socialize at all hours, so long as the noise doesn’t bother people sleeping in the buildings next door and no rules listed are broken. Woodside Restaurant with good food, beer/wine and games is within a short walk of the meeting space and bunkhouses. **Bring a flashlight for walking to the Party Nest and Woodside Restaurant.**

Other Logistics

Check in and check out time are inflexible so we can't give you any grace because the State Park doesn't give us any.

The bunks are a very short walk from our meeting space.

The Learning Campus has campus wide WiFi.

Rules

Quiet hours 9pm to 7am

No crime, vandalism, drugs, or disruptive or disrespectful behavior.

No talking/laughing/crying/sex/upset babies, etc. in or within ear shot of the sleeping area during quiet hours.

For noise reasons, we ask that you only stay in the bunkhouse if you and your children and guests can observe the quiet hours. We love babies, but If you have babies that cry at night, the bunkhouse is not a good fit. Bunkhouses are not child proof. Parents and guardians are responsible for supervision of their children. While partners are welcome, be very discrete with nudity and affection. Assume that others don't want to see it.

Leave common spaces as clean as you found them.

Use headphones for electronics in the sleeping area. **Bring headphones.**

Please promptly report any housing problems to seminar staff. But try not to cause any housing problems. Seminar staff need downtime too.

By staying in the bunkhouse you agree to follow staff direction and to vacate immediately at staff request.
