#### DIRECTIONS TO DOWNLOAD ELECTRONIC ADOPTION LIBRARY

When you are ready to download your Adoption Library:

Begin on the computer where you want the files to download. Go to your order confirmation email. Log in to your goodlawtn account using the link found in your email and your password. If you haven't set up a password for your goodlawtn account, you will need to do that before you proceed. Once on your goodlawtn account page, you will see "1 download remaining" for 2024 Coppock 8<sup>th</sup> Adoption Library. Click the download link and the Library will automatically download to your computer .

On your computer, save your Adoption Library in a place that is convenient for long-term access. The practice forms are saved as Word Templates to avoid inadvertent overwriting. Documents prepared using a template must be saved using a name different than the original template name. Adding a client name and date to this template file name, using the "save as" function works well.

One download is included with the book purchase. The initial download link will not work twice. You may reuse your downloaded forms saved on your computer an unlimited number of times.
